

2 Free Trial Lessons – Limited Time Offer (1 September to 30 September 2026)

1. “We” and “Kingswim” are YMCA Aquatic Education Ltd (ABN 88 151 552 322) trading as Kingswim of 2 St Catherine’s Court, Mornington, Victoria, telephone (03) 5976 3777.
2. Information on eligibility, how to claim and the offer form part of these Terms and Conditions (**Terms**).
3. Use of the offer (**Offer**) is deemed acceptance of these Terms.
4. Use of this Offer may also require you to agree to terms and conditions of entry posted at the applicable Kingswim centre. In using this Offer, you must agree to and abide by such posted terms and conditions of entry.
5. Offer: The offer is two free introductory/first lessons for a swimmer to try the Kingswim learn to swim program and find out if it is right for them. The value is two 30-minute regular lessons at the allocated Kingswim centre, dollar value varies per centre. The actual date of the introductory lessons may fall outside of these dates, but the first lesson will be no later than 07 October 2026. There is no obligation to sign up following the trial lessons, however if the swimmer would like to they will need to enrol and pay a \$20 enrolment fee to book into a regular lesson as well as usual class charges.
