

Terms & Conditions – Kingswim 50% Off Lessons in January 2026

1. “We” and “Kingswim” are YMCA Aquatic Education Ltd (ABN 88 151 552 322) trading as Kingswim of 2 St Catherine’s Court, Mornington, Victoria, telephone (03) 5976 3777.
2. Information on eligibility, how to claim and the offer form part of these Terms and Conditions (**Terms**).
3. Use of the offer (**Offer**) is deemed acceptance of these Terms.
4. Use of this Offer will also require you to agree to and abide by Kingswim Terms and Conditions posted on the Kingswim website, <https://www.kingswim.com.au/kingswim-terms-and-conditions/>.
5. **Offer:** The Offer is one free introductory lesson and 50% off all further lessons in January 2026. The introductory lessons is for a swimmer to try the Kingswim learn-to-swim program and find out if it is right for them. There is no obligation to enrol following the trial lesson.
