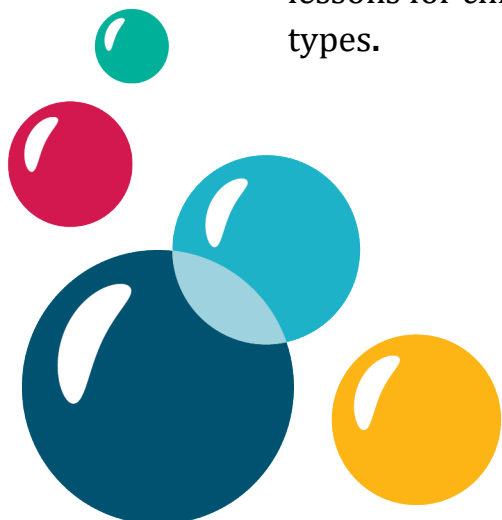


Terms & Conditions – Kingswim 50% Off a Second Lesson from May - August 2026

1. “We” and “Kingswim” are YMCA Aquatic Education Ltd (ABN 88 151 552 322) trading as Kingswim of 2 St Catherine’s Court, Mornington, Victoria, telephone (03) 5976 3777.
2. Information on eligibility, how to claim, and the Offer form part of these Terms and Conditions (**Terms**).
3. Use of the Offer (**Offer**) is deemed acceptance of these Terms.
4. Use of this Offer will also require you to agree to and abide by Kingswim Terms and Conditions posted on the Kingswim website, <https://www.kingswim.com.au/kingswim-terms-and-conditions/>.
5. **Offer:** The Offer is 50% off a second regular lesson for all current, lapsed and new swimmers enrolled in K1-11 lesson levels. The Offer is available between May and August 2026. If the swimmer is new to Kingswim, an introductory lesson is available for the swimmer to try the Kingswim learn-to-swim program and find out if it is right for them. They will need to pay a \$20 enrolment fee and book into a regular lesson, they can then claim 50% off their second regular lesson as part of this Offer. The regular price of lessons is between \$26.30 and \$27.50, and prices will revert to the regular price after the Offer expires.
6. **Eligibility:** To be eligible to claim this Offer, the claimant must enrol in two lessons per week during the offer period. The first lesson will be charged at the full price, and the second lesson will be charged at 50% of the full lesson price. If a claimant enrolls in a private lesson during the offer period, they will be eligible to enrol in a second group lesson at 50% of the full lesson price. Lesson prices may vary slightly between Kingswim centres. This Offer is available for group learn-to-swim lessons for children or adults and is not eligible for any other lesson types.



7. **Exclusions:** Offer is not eligible for Private Lessons, Baby Play, Hydrotherapy, Member Swim, and Aquacise. Offer is available at all Kingswim centres in Victoria, Australian Capital Territory and New South Wales.
8. The Offer commences at **1am AEST on Friday 01 May 2026** and ends (closing date) at **8pm on Monday 31 August 2026**.
