Terms and Conditions – Stay on Track & Win

The Promotion

- 1. "We", "Us", "Our" and "Promoter" are YMCA Aquatic Education Ltd (ABN 88 151 552 322) of 2 St Catherine's Court, Mornington, telephone (03) 5975 0777 (Kingswim).
- 2. These terms and conditions (**Terms**) govern the 'Stay on Track & Win' promotion being run by the Promoter (**Promotion**).
- 3. Participation in the Promotion is deemed acceptance of these Terms (including any subsequent variations to these Terms as provided in clause 13).
- 4. Subject to these Terms, all eligible persons will be entered into the monthly prize draw to win one of 20 prizes. Eligibility

- 8. The Promotion is automatically open to parents/guardians of a currently enrolled swimmer:
 - a. The swimmer must be a current enrolled Kingswim swimmer, meaning they are currently enrolled and participating in group or private learn to swim lessons at any Kingswim centre in Australia;

Legal
