

## Terms and Conditions – Swim into Festive Fun

1. **"We", "Kingswim" and "Promoter"** are YMCA Aquatic Education Ltd (ABN 88 151 552 322) of 2 St Catherine's Court, Mornington, telephone (03) 5975 0777.
2. Information on eligibility, how to enter and the prize form part of these Terms and Conditions (**Terms**).
3. Participation in this Promotion (**Promotion**) is deemed acceptance of these Terms (including any subsequent variations to these Terms as provided for in these Terms).
4. The Promotion includes seven (7) random prize Draws (**Draw**) per Kingswim swimming centre (18 centres total). Each prize draw consists of: 2 prizes of one month of free swimming lessons for one child or adult (1 lesson per week) up to a value of of \$136.50 and 5 prizes of a Kingswim swimming bag filled with goodies with a value of \$50.00.
5. Eligibility: Registered customers, including parents or guardians on behalf of their children, who meet the following criteria will be eligible to enter the Draw:
  - a. must be a current Kingswim member at the time of the Draw, meaning they/their child are currently enrolled and participating in group or private learn to swim lessons or classes at any Kingswim centre in Victoria, Australian Capital Territory or New South Wales;

7. The Promotion commences at 7am AEDT on Wednesday 27 November 2024 and ends (closing date) at 9am Friday 13 December 2024 (Promotional Period).
8. The Promoter will automatically submit entries on behalf of all eligible persons to the Draw. Entrants are not able to submit entries themselves.
9. Draw date: the Prize Draw will take place at Kingswim Head Office, 2 St Catherine's Court, Mornington, Victoria, 3931 at 12pm on Friday 13 December 2024.
10. Notification: The winners will be notified by email within 48 hours after the Prize Draw.
11. Prize: There are 36 prizes of: one month of free lessons for one child. The prize value is based on one group lesson per week for four weeks and is valued between \$100 and \$136.50 in total. The prize is not transferable, exchangeable, or redeemable for cash.
12. Claiming the prize: The winner will be notified that they have won the Draw. The Prize will be applied as a credit to the family account and used in the next billing period.
13. These terms and conditions may be amended by us at any time.

14. Reservation of rights: The Promoter reserves the right, at any time, to verify the validity and eligibility of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
15. Game of chance: This Promotion is a game of chance. Each winner will be selected randomly from the pool of valid entries and, subject otherwise to these Terms, skill plays no part in determining the winner. Each valid entry will not be individually judged.

Legal: Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**").

Exclusion of liability: Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including in negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any tax liability incurred by a winner or entrant; (e) taking and/or use of the prize; or (f) the Promotion.
