## Terms and Conditions – Win a Year of Swimming Lessons

- 1. "We", "Kingswim" and "Promoter" are YMCA Aquatic Education Ltd (ABN 88 151 552 322) of 2 St Catherine's Court, Mornington, telephone (03) 5975 0777.
- 2. Information on eligibility, how to enter and the prize form part of these Terms and Conditions (**Terms**).
- 3. Participation in this Promotion (**Promotion**) is deemed acceptance of these Terms (including any subsequent variations to these Terms as provided for in these Terms).
- 4. The Promotion includes four (4) random prize Prize Draws (Prize Draw). The prize draw consists of: 1<sup>st</sup> prize of a year of free swimming lessons for one child or adult in 1 group lesson per week for 47 weeks (all weeks Kingswim is open in a calendar year) up to a value of \$1303.10; and 3 prizes of six months of swimming lessons for one child or adult in 1 group lesson per week for 24 weeks, up to a value of \$675.20.
- 5. Eligibility: Adults aged 18 plus, including parents or guardians on behalf of their children, who meet the following criteria will be eligible to enter the Prize Draw:

- 8. Entry Submission: Participation in the competition is exclusively available through an official entry form, which can only be submitted at the Kingswim family event held on 01 December at Queensbridge Square, Southbank. The competition will be advertised solely at this event.
- 9. Eligibility and Limitations: Each participant is permitted to submit only one entry. Multiple entries from the same individual will be disqualified to ensure fairness and adherence to the competition rules.
- Event-Specific Entry: Entries are valid only if submitted using the designated entry form on 01 December. Participants must ensure that all information provided on the entry form is accurate and complete.

- 11. General Terms: By submitting an entry, participants agree to comply with all competition terms and conditions as announced at the event. The organiser's decisions regarding all aspects of the competition are final and binding.
- 12. Draw date: the Prize Draw will take place at Kingswim Head Office, 2 St Catherine's Court, Mornington, Victoria, 3931 at 12pm on Wednesday 04 December 2024.
- 13. Winner Selection Process: The winners of the Prize Draw will be selected through a random selection process. All eligible entries will be compiled, and a random drawing will be conducted to determine the winners.
- 14. Notification of Winners: Winners will be notified via the contact information provided at the time of entry within 7 business days following the draw. Notifications will be sent via email or phone and winners will be required to confirm receipt of this notification.
